OVERVIEW

Our SMS program allows customers to text our business phone number (956-540-7080) with questions about product availability, pricing, store hours, and location. Our employees respond directly to customer inquiries. This program does not send unsolicited marketing or promotional messages.

2. Consent and Enrollment

You are enrolled in this messaging program when you voluntarily text our business phone number first. No further action is required to receive a reply. There is no keyword-based opt-in; consent is established by your initiating contact with us.

3. Message Frequency and Fees

Message frequency varies depending on your conversation with our team. Message and data rates may apply. Please check with your mobile carrier for details on your messaging plan.

4. Opt-Out and Help

To stop receiving messages at any time, reply STOP, CANCEL, END, QUIT, UNSUBSCRIBE, REVOKE, or STOPALL. You will receive a one-time confirmation that you have been unsubscribed. To resubscribe, reply START. For help, reply HELP or INFO, and you will receive assistance instructions along with a reminder that message and data rates may apply.

5. Alcohol-Related Inquiries

If you text us to ask about the availability of alcohol products, you represent and confirm that you are at least 21 years of age. We do not sell, process payment for, or promote alcohol products via SMS — inquiries are limited to general availability information.

6. Eligibility
